Management Report - Agenda Items

2020/2021 Budget Proposal

Sue would also like to see all porch lights hardwired (to be on when dark). Miller told her that this is done when a Member moves out. The Board must give approval to hardwire all porch lights.

Sue is concerned about the amount of foot traffic by her townhouse and the shooting that happened across Miller earlier in 2020. She has safety concerns for herself and neighbors. It is too dark and she cannot give the police descriptions of people outside her townhouse after dark. A car was broken into last week in her parking lot. She wanted to know if there was a robo call about the incident. Miller said that this is usually done, but not this one.

Sue Pride, 6116 Balfour and Candy Miller, 6148 Balfour

Sue and Candy would like additional lighting in the backyards of their townhouses for safety reasons. They would pay the electric bill for the additional lighting. Miller will have maintenance check out their location and yard to see how this could be done.

Felicia Zapata, 6118 Balfour

Felecia inquired about the pine trees in the front along Miller Road. She wants to know if there are plans to replace the ones that were removed. Miller explained that some of the trees were removed since they were fighting each other for sunlight. The remaining trees have had growth due to the trees that were removed.
