Member Concerns

Sandra Drumm, 6215 Haag

Sandra said that the kitchen floor is not in good shape in her townhouse. It was last replaced in 1998. She has not called the Office to request that the flooring be replaced and was informed that she needs to do so.

Kari commented on the porch hand rails. She thinks that everyone should be able to get a rail on their porch that wants one. She wants this changed so that a doctor's note is not required. N. Miller said that the Member can hire someone and pay for a hand rail to be installed. An Alteration Permit is required prior to beginning the project. The Board to discuss.

She also commented that maintenance does a good job, however, can they leave a note that says what they did? Liz Smith asked what is missing from the colored card that is left now? Kari said it is missing the details of what was done and if they are coming back. N. Miller said that in the future, emails might be sent to accomplish this.

Linda asked if vinyl hand rails have been considered like the ones at Woodbridge? The metal one's rust. She has put primer on and painted her hand rail, but the salt makes them rust.

Linda asked if she can have a hand rail installed on her back porch? She has one on front porch due to a broken neck. N. Miller said she needs a new doctor note if the previous doctor note specifically states front porch.

Sue Pride, 6116 Balfour

Sue asked if the updated policy handbook is completed yet? N. Miller said no, but it is being worked on.

Sue wanted to know if carrying charges are going up this year? N. Miller explained that the budget process starts in July and is approved by the Board in September.

Sue asked if the maintenance staff can wear booties when they enter a townhouse to do some work? N. Miller said that this will be checked into. In the past, there has been some issues with slipping. Someone said that some booties have grippers on bottom to prevent slipping.

She also inquired when the grounds staff will begin mowing? N. Miller said that the mowing should begin this week.
