Sue asked if she can order some garbage bags. This was discussed at a previous meeting. N. Miller said that she is still checking into this. Members will be required to pay up front when placing an order.

The Carrying Charges went up \$17.00, but some Members are noticing that their Carrying Charges went up \$3.00. Why is this? N. Miller said that due to rounding, the amount may be more than the \$17.00. This is usually a dollar. For Members paying the surcharge, it is 10% higher than the stated Carrying Charge amount. She will check into why some Members may have increased \$3.00.

She also asked about porch bulbs. She noticed that some are yellow versus white. N. Miller said that Highlands has 2 types of porch bulbs. One is a bright white and some are yellow. Some Members don't want the bright white bulbs.
