One week prior to the annual meeting, election information and procedure package will be sent out. Also included will be information on how to win \$50 and \$100 gift cards.



Water and gas valve replacement program update

We would like to provide an update on the ongoing project to replace the water and gas valves in all 414 townhouses, as you know Highlands is working with Parker Arntz and Consumer Energy on this important initiative. We have now completed the valve replacements in approximately half of the townhouses. We want to acknowledge that this process is taking longer than initially expected, and we have encountered some unforeseen setbacks. These setbacks have unfortunately led to instances where Consumers Energy has had to reschedule or even cancel work that was already planned, sometimes with very short notice.

Please know that we are doing our utmost to adhere to the scheduled dates and to inform you of any necessary changes as quickly as possible once we receive notification. Unfortunately, these cancellations and reschedules are outside of our control, as well as that of Consumers Energy, and can be due to factors such as weather conditions or material shortages.
