Alteration Permit Policy

N. Miller presented the Board with some changes to the Alteration Permit Policy.

The first is to clarify that any mounting or drilling of holes in exterior walls, windows, or doorways requires an alteration permit to be filled out and approved before this is done. The second is that an \$100 fine will be assessed, if the Alteration Permit Policy is not followed. Heist moved to approve the changes to the policy with the correction to change assessed to assessed. Kniffin seconded.

Tree Removal Proposal

Kniffin moved to approve Green Point Consulting to remove 6 trees on the property that are showing signs of deterioration which creates a danger of future building damage. Also, there are several trees that need extensive pruning to provide building clearance. The total cost is \$10,798. Heist seconded.

may attract animals such as skunks, etc. Melissa to provide a flier to the Office from another area in Lansing that does composting.

Terri Adams, 6308 Haag

Terri asked if the chain at the trash area on weekends doing its job? Also, is there a savings by doing this? N. Miller said that the chain is doing what we wanted it to do by Non-Members being turned away from dumping their trash and large items. This has been viewed on the camera. Highlands is charged extra by our trash company to take the extra items and this is a lot less than before the chain was put up. Also, the staff does not have to spend an hour or more on Monday morning to clean up the mess from the extra trash dumped.
